North Carolina's Eastern Region Appoints Military Growth Task Force

Kinston, N.C., December 13, 2007 – At their regularly scheduled monthly board meeting today, The North Carolina's Eastern Region (NCER) Board of Directors made the initial appointments to the newly created Military Growth Task Force (MGTF).

The Military Growth Task Force, a special committee of the 13-county Eastern Region Economic Development Partnership has been established to plan for and address impacts resulting from the increase in force strength of United States Marine Corps at MCB Camp Lejeune, MCAS New River and MCAS Cherry Point.

As a result of the congressionally approved increase in marine strength nationally, the three marine installations located in Onslow County and Craven County are expected to add approximately 11,500 marines and 13,500 dependents and other civilians to the regional population by FY 2011. The direct impact of the military-related increase of 25,000 people will induce an additional growth in population of 15,000 people. This growth is in addition to the normal (unrelated to the military) projected increase in population by 2010 of over 21,000 persons. Thus, the seven county affected region that includes Onslow, Craven, Carteret, Duplin, Jones, Pamlico and Pender counties will see an overall population growth exceeding 61,000 in the next three years.

As a part of its actions today, the NCER Board also approved an initial \$100,000 in funding for the Military Growth Task Force. These funds are to be used as a match towards securing federal planning funds from the U.S. Department of Defense (DoD), Office of Economic Adjustment (OEA). The initial application for DoD, OEA funding is expected to be approximately \$1 million in the first year and be submitted for approval in the first quarter of 2008.
